A complete set of bidding Documents may be purchased from the office CIAA, Tangal by eligible Bidders upon payment of a non-refundable fee of NRs. 1000.00 till 2076/02/24 during office hours. Eligibility criteria of the Bidders are specified as below:
  - a) *Up to date Firm/Company Registration Certificate*
  - b) *VAT and PAN Registration Certificates*
  - c) *Tax Clearance Certificate for the Fiscal Year 2074/075*
  - d) *Power of Attorney to sign the Sealed Quotation*
3. Sealed bids must be submitted to the office CIAA, Tangal by hand on or before *12:00 noon* on 2076/02/26. Bids received after this deadline will be rejected.
4. The bids will be opened in the presence of Bidders' representatives who choose to attend at *2076/02/26 2:00pm at the office of CIAA, Tangal*. Bids must be valid for a period of *45 days* after bid opening and must be accompanied by a bid security amounting to a minimum of *Rs. 50000*, which shall be valid for *30 days* beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit A/C No. *1000200010000* at Rastriya Banijya Bank, Thamel, Branch of District Treasury Controller Office Kathmandu payment Center No. 3 (*CIAA's Office code no. 206003501*) and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
5. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
6. The Purchaser reserves the right to accept or reject, wholly or partly any or all the Sealed Quotations without assigning any reason, whatsoever.
