Bidder must to submit their bid electronically through egp II system of ppmo: www.bolpatra.gov.np/egp or before 12:00 hrs 2077/12/12(25th March, 2021) : may download the bidding documents for e-submission from PPMO's e-GP system (www.bolpatra.gov.np/egp). Bids received after this deadline will be rejected.
6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 12th Chaitra, 2077(25th March, 2021) at 13:00 Hours at the office of Commission for the Investigation of Abuse of Authority, Tangal, Kathmandu. Bids must be valid for a period of 90 Days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format in case of e-bid, amounting to as mentioned in the table below which shall be valid upto 8th Shrawan, 2078 (23rd July, 2021).
