3. *A complete set of bidding Documents may be purchased from the office CIAA, Tangal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 1000.00 till 2077/07/27 during office hours.*
4. *Sealed bids must be submitted to the office CIAA, Tangal by hand on or before 12.00 on 2077/07/28 Bids received after this deadline will be rejected.*
5. *The bids will be opened in the presence of Bidders' representatives who choose to attend at 2077/07/28, 2.00 pm at the office of CIAA, Tangal. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Rs. 35000, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit A/C No. 1100203000000 at Rastriya Banijya Bank, Thamel Branch of District Treasury Controller Office Kathmandu payment Center No. 3 (CIAA's Office code no. 206003501) and submit the receipt of the deposited amount of cash along with the Sealed Quotation.*
6. *If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.*
