1. The Commission for the Investigation of Abuse of Authority(CIAA) invites sealed quotations from registered Suppliers for the supply and delivery of Purified Drinking Water.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at Internal Management Section, Commission for the Investigation of Abuse of Authority(CIAA), Tangal, Phone No.015262111 for further details.
3. A complete set of bidding Documents may be purchased from the **Internal Management Section, Commission for the Investigation of Abuse of Authority(CIAA),Tangal** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **NRs.1,000.00 (One Thousand Rupees) till date 2080/10/3** during office hours.
4. Sealed bids must be submitted to the **Internal Management Section, Commission for the Investigation of Abuse of Authority (CIAA),Tangal** by hand **on or before 12:00 on date 2080/10/4**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2080/10/4, 2:00 pm at the Internal Management Section,Commission for the Investigation of Abuse of Authority(CIAA),Tangal**. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **Rs.50,000.00 (Fifty Thousand Rupees)**, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit A/C No. 1100100102030000 at Rastriya Banijya Bank, Thamel Branch of District Treasury Controller Office Kathmandu payment Center No. 3 (CIAA's Office code no. 206003501) and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. The Purchaser reserves the right to accept or reject, wholly or partly any or all the Sealed Quotations without assigning any reason, whatsoever.
