4. Pre-bid meeting shall be held at CIAA, Tangal, Kathmandu on date 13<sup>th</sup> Baishakh, 2078 (26<sup>th</sup> April 2021) at 13:00 hrs.
5. Bidder must submit their bid electronically through egp II system of ppmo: www.bolpatra.gov.np/egp on or before 2078/01/26 (9<sup>th</sup> May, 2021) at 12:00 hrs: may download the bidding documents for e-submission from PPMO's e-GP system (www.bolpatra.gov.np/egp). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2078/01/26 (9<sup>th</sup> May, 2021) at 13:00 hrs at CIAA, Tangal, Kathmandu. Bids must be valid for a period of 90 Days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to as mentioned in the table below which shall be valid minimum 30 days beyond the bid validity period [i.e.22<sup>nd</sup> Bhadra, 2078 (7<sup>th</sup> September, 2021)].
7. If the last date of submission and opening falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
